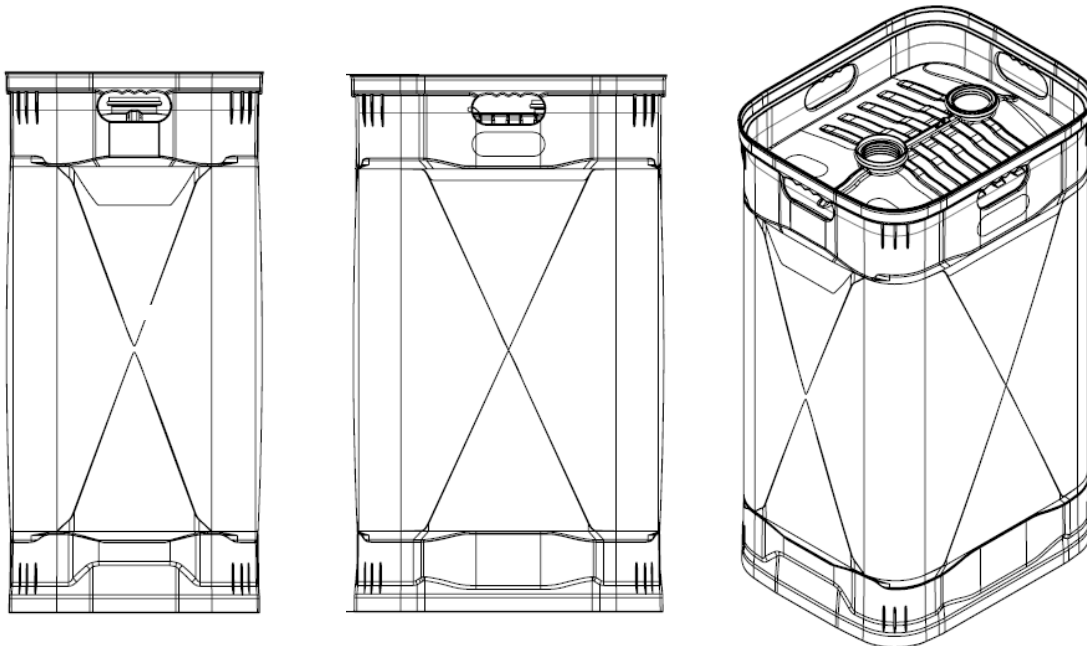

Decorating	Container flamed on the recessed panels to improve adhesion of labels and inks. Container may also be custom sleeved in-line or post labelled at an extra charge.
Colour	The keg body is white. The top and bottom rings can be customized as per request.
Stacking	Containers nest together to improve stability during storage. Containers can be arranged 6 units per layer (2 x 3) on a standard 40"x48" pallet. Recommended stack height for filled containers using products with SG of 1.4 is 3 layers on 2 pallets, for a total of 6 layers high. Pallet loads must be strapped and/or stretch wrapped to secure the load. The use of double-faced pallets is recommended, with stacks evenly spaced that no tighthead overhangs the edge of the pallet.
Handle	Four evenly spaced handles located at the top ring for handling and ease of pouring.

FILLING RECOMMENDATIONS

- Compatibility of the bottle with the fill product is the responsibility of the filler.
- Contents should not exceed 70°C (158°F) at time of fill.
- Filled containers should not be stacked and stored above 50°C (122°F)
